A Dangerous Goods Safety Adviser (DGSA) must be appointed by any business that regularly ships Dangerous Goods by Road and their duties include an annual report to assess compliance with The Regulations and give advice on any improvements that should be considered.

The role of a DGSA is limited for most businesses who deal with international trade or complicated products and supply chains.
